TERMS AND CONDITIONS OF SALE

ACCEPTANCE OF BUYER'S ORDER IS CONDITIONAL ON BUYER'S AGREEMENT TO THE TERMSAND CONDITIONS BELOW. PLACEMENT OF AN ORDER WITH GRAFTEK IMAGING, INC. CONSTITUTES ACCEPTANCE OF THESE TERMS AND CONDITIONS.

1) Controlling Law: The terms and conditions contained herein shall be governed by the laws of the State of Texas and the laws of the Federal Government of the United States.

2) Cancellations and Returns: No order, once placed, may be cancelled for any reason without written consent of the Seller and Seller will not accept return of goods unless authorized in a written "Authorization of Return Material" prior to return shipment. Any return shipment must be made in accordance with Seller's return policy and instructions.

3) Taxes: Prices do not include any taxes applicable to the goods sold on this transaction. Taxes will be added by Seller to the sales price where Seller invoices the same to comply with any state, federal or local law, and will be paid by Buyer unless Buyer provides Seller with a proper tax exemption certificate.
4) Prices: Price quotations must be in writing to be binding on Seller and are valid for 30 days from the time of creation or latest revision, or for the time stated on the guotation. All prices are in U.S. Dollars.

5) Title and Delivery: Prices do not include charges for shipping. Buyer will be responsible for all delivery charges unless otherwise stated in writing by the Seller. All shipments of goods shall be delivered F.O.B. Point of Origin, and title and liability for loss or damage thereto shall pass to Buyer upon Seller's delivery of the goods to a carrier for shipment to Buyer, and any loss or damage thereafter shall not relieve Buyer from any obligation hereunder. Buyer shall be liable for costs of insurance and transportation and for all import duties, taxes, excises, fees, assessments and any other expenses incurred or licenses or clearance required at port of entry and destination. Seller may deliver goods in installments unless otherwise specified at time of order. Shipping dates are approximate only. Seller shall not be liable for any loss or expense, whether by way of contract or tort, (consequential or otherwise) incurred by Buyer if Seller fails to meet the specified estimated delivery schedule because of unavoidable production or other delays. Delivery date(s) acknowledged or quoted by Seller and all shipping dates are approximate and not guaranteed.

6) Terms and Method of Payment: Where Seller has extended credit to Buyer; terms of payment shall be net thirty (30) days from date of invoice. The amount of credit or terms of payment may be changed, or credit withdrawn by Seller at any time. If the goods are delivered in installments, Buyer shall pay Graftek Imaging, Inc. separately for each installment. Payment shall be made for the goods without regard to whether Buyer has made or may make any inspection of the goods. If shipments are delayed by Buyer, payments are due from the date when Seller is prepared to make shipments. Goods held for Buyer are at Buyer's risk and expense.

7) WARRANTIES: PRODUCTS SOLD BY GRAFTEK IMAGING, INC MAY INCLUDE A LIMITED MANUFACTURER WARRANTY. GRAFTEK IMAGING DOES NOT ACCEPT ANY RESPONSIBILITY OR LIABILITY FOR THE DURATION, EXTENT OR CONDITIONS OF SUCH WARRANTIES. SELLER HEREBY DISCLAIMS ALL IMPLIED WARRANTIES, INCLUDING ANY IMPLIED WARRANTY OF FITNESS FOR A PARTICULAR PURPOSE OR IMPLIED WARRANTY OF MERCHANTABILITY, AND ANY EXPRESS WARRANTIES NOT CONTAINED IN THIS AGREEMENT. NO OTHER WARRANTIES ARE GIVEN UNLESS EXPRESSLY WRITTEN BY SELLER. SELLER HEREBY SELLS THE GOODS AND BUYER HEREBY PURCHASES THEM "AS IS, WHERE IS."

8) LIMITATION OF REMEDY AND LIABILITY: THE SOLE AND EXCLUSIVE REMEDY FOR BREACH OF ANY WARRANTY OR CLAIM AGAINST SELLER UNDER THIS AGREEMENT SHALL BE LIMITED TO REPAIR, CORRECTION OR REPLACEMENT, OR REFUND OF THE PURCHASE PRICE PAID BY BUYER. SELLER SHALL NOT BE LIABLE FOR DAMAGES CAUSED BY DELAY IN PERFORMANCE AND IN NO EVENT, REGARDLESS OF THE FORM OF THE CLAIM OR CAUSE OF ACTION (WHETHER BASED IN CONTRACT, INFRINGEMENT, NEGLIGENCE, STRICT LIABILITY, OTHER TORT OR OTHERWISE), SHALL SELLER'S LIABILITY TO BUYER AND/OR ITS CUSTOMERS EXCEED THE PRICE PAID BY BUYER FOR THE SPECIFIC GOODS PROVIDED BY SELLER GIVING RISE TO THE CLAIM OR CAUSE OF ACTION. All software license terms are established directly between the Customer and the manufacturer of the software. Unless Graftek Imaging Inc. is identified as the owner or licensor of the software, Graftek Imaging Inc. is not a party to any software license terms and Graftek Imaging Inc. makes no warranties or representations related to the ownership, use or operation of the software.

10) Legal Compliance: Buyer, at all times, shall comply with all applicable federal, state and local laws and regulations. Export of the products covered by this quotation or acknowledgment may be subject to export license control by the U.S. government. It is Buyer's responsibility to obtain any licenses which may be required under the applicable laws of the U.S. including the Export Administration Act and regulations promulgated thereunder.

11) Non-Waiver of Default and Collection Rights: In the event of any default by Buyer, Seller may invoke any remedy provided by law or by the terms herein stated, and may decline to make further shipments. If Seller elects to continue to make shipments, Seller's actions shall not constitute a waiver of any default by Buyer or in any way affect Seller's legal remedies for any such default. In the event Seller resorts to a third party or to litigation in order to collect amounts due Seller, Buyer agrees to pay costs of collection for amount owed to Seller, including, but not limited to, attorney's fees, court costs, and interest in the amount of 1% per month (12% per annum) or the maximum rate permitted by law, whichever is lowest, from the date the amount is due.

12) This purchase does not include technical support beyond one hour of telephonic (or via email) support, and does not include application development or consulting unless otherwise noted in writing.

13) Venue/Jurisdiction. The parties agree that any controversy, claim, dispute or disagreement arising under, out of, or related to this Agreement shall be brought, to the exclusion of all other courts, in state or federal courts located in Travis County, State of Texas, U.S.A. The parties hereby consent and submit to the personal jurisdiction and venue of such courts for the resolution of such controversies, claims, disputes or disagreements.

14) Indemnity.
